**ORDER**

Whereas, Shri Ravikant Shukla vide Offline RTI appeal bearing dated 24.07.2025 received on preferred an appeal under Section 19(1) of the RTI Act, 2005 against his RTI application bearing Registration no. MOCAV/R/P/25/00045 dated 09.06.2025 under the Right to Information Act, 2005.

2. And whereas, Shri Shukla vide his original application under RTI Act, 2005 had sought information on various points pertaining to Heliport and CASO Policy.

3. And whereas the information sought was not available in the maintained records with the answering CPIO, AAI Section, Ministry of Civil Aviation, and it was felt that the information may pertain to another CPIO of this Ministry (DT Section), managed by a separate CPIO. Therefore, the RTI application was transferred to the CPIO, DT Section under Section 6(3) of the RTI Act, 2005 for furnishing information to the applicant directly and the applicant was informed accordingly vide letter dated 26.06.2025.

4. And whereas, the appellant has informed that he has neither received any attachment with the reply (mentioning the details of CPIO to whom RTI application was transferred) vide letter of even number dated 26.06.2025 nor received any information from another CPIO. A copy of reply dated 26.06.2025 along with attachment is being forwarded herewith to the appellant.

5. And whereas, requisite information is concerned, it is learned that the CPIO, DT Section has further transferred RTI application to the CPIO, Director General of Civil Aviation (copy enclosed) as information was not available in their records.

6. As such, the reply dated 26.06.2025 given to the applicant by the CPIO, AAI Section, Ministry of Civil Aviation, is found to be in order, and there appears to be no merit in the instant RTI appeal. However, a copy of the same along with screenshot is being forwarded to the appellant.

7. And whereas, the appellant may approach to the CPIO / FAA, DGCA, for the requisite information.

8. In view of the above, the instant appeal is hereby disposed of.
