

Subject: Conditional exemption from Unmanned Aircraft System (UAS) Rules, 2021 to Directorate of Urban Local Bodies (DULB), Haryana for data acquisition, mapping and implementation of web based GIS platform for development of AMRUT cities and property tax survey for Hisar, Panchkula, Ambala urban areas using drones

1. Whereas, DULB ("the Applicant") had, vide email dated 04 June 2021 sought an exemption from UAS Rules, 2021 for the afore-mentioned purpose.
2. Whereas, based on the undertaking provided by the Applicant, Directorate General of Civil Aviation (DGCA) vide letter no. DGCA-31031/14/2021-Drone-Dte dated 14 June 2021, accorded approval of the Standard Operating Procedure (SOP) for the afore-mentioned purpose.
3. Now, therefore, the Central Government, in exercise of the powers conferred by Rule 70 of the UAS Rules, 2021, grants conditional exemption from UAS Rules, 2021 to the Applicant for the afore-mentioned purpose. This exemption shall be subject to the terms and conditions of the said SOP and shall be valid for a period of one year from the date of approval of the said SOP or until further orders, whichever is earlier.


